A RESOLUTION RESCINDING COUNTY OF SANTA FE, RESOLUTION NO. 2008 -189, TO CORRECT AN INCORRECT DATE, AND AUTHORIZING LEGAL HOLIDAYS AND CLOSING OF COUNTY OFFICES FOR CALENDAR YEAR 2009

WHEREAS, the Board of County Commissioners proposes to allow certain legal holidays to be observed as non-working days for employees of Santa Fe County; and

WHEREAS, it is incumbent upon all employees to be allowed the opportunity to celebrate these historic events.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Santa Fe County that the following dates shall be observed as legal holidays and non-working days by the employees of Santa Fe County. Firefighters on 207K exemption will observe holidays on the ACTUAL Holiday.
