**A RESOLUTION REQUESTING FUNDING THROUGH THE 2009/2010
LOCAL GOVERNMENT ROAD FUND PROGRAM, SB FUNDING, CHIP
SEAL IMPROVEMENTS ON COUNTY ROAD 17, NEW MEXICO
DEPARTMENT OF TRANSPORTATION**

WHEREAS, the Board of County Commissioners (hereafter referred to as “the Board”) desires to utilize funding made available through an application submitted to the New Mexico Department of Transportation’s LGRF (Local Government Road Fund) Program for various County road improvement projects: and

WHEREAS, upon approval of the application submitted to the New Mexico Department of Transportation (hereafter referred to as “the Department”) funding will be received in the form of Cooperative Agreement - SB: and

Scope of Work: Chip Seal Improvements.
