A RETROACTIVE RESOLUTION FOR DONATION OF SHERIFF'S DEPARTMENT PERSONAL PROPERTY

WHEREAS, Santa Fe County has disposed of certain personal property identified in Exhibit A, attached; and

WHEREAS, Exhibit A details each item of personal property by department or office, equipment description, Santa Fe County property tag number, serial number, condition of equipment, and estimated fair market value; and

WHEREAS, the Sheriff's Department, Colfax County, New Mexico, requested the donation of obsolete radios, radar equipment, and one desk from the Santa Fe County to use in assisting its personnel in their job duties; and

WHEREAS, the requested equipment had an estimated current resale value of five thousand dollars (\$5,000) or less and was unusable by the County.

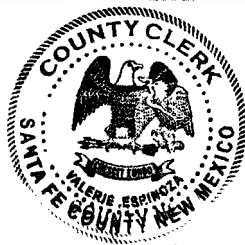
