**A RESOLUTION AUTHORIZING THE COUNTY TO SUBMIT  
GRANT APPLICATIONS TO U.S. BUREAU OF  
RECLAMATION – UPPER COLORADO REGION WATER  
CONSERVATION FIELD SERVICES PROGRAM FOR  
DEVELOPMENT, IMPLEMENTATION, AND OUTREACH  
FOR THE COUNTY WATER CONSERVATION PROGRAM**

WHEREAS, the Board of County Commissioners of Santa Fe County adopted an ordinance addressing water conservation, Ordinance No. 2002-13 (“the Water Conservation Ordinance”), later amended by Ordinance Nos. 2004-07, 2006-3 and 2006-8;

WHEREAS, the Santa Fe County Land Development Code, Ordinance No. 1996-10, and the Water Conservation Ordinance recognize the need for residential and commercial water uses to implement water conservation practices;

WHEREAS, the County Water Resource Specialist is responsible for the development and implementation of the County Water Conservation Program;

WHEREAS, obtaining additional funding sources for the Water Conservation Program will help facilitate the Water Conservation Program development, implementation, and public outreach activities


WHEREAS, the water resource specialist has identified the U.S. Bureau of Reclamation—Upper Colorado Region Water Conservation Field Services Program (WCFSP) Grants as a potential source of funding for the County Water Conservation Program development, implementation, and public outreach activities; and

WHEREAS, if awarded, the WCFSP Grant funding will greatly enhance the implementation of the Water Conservation Program development activities.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Santa Fe County that submission of applications for U.S. Bureau of Reclamation—Upper Colorado Region WCFSP Grants is hereby authorized.


