**A RESOLUTION FOR SURPLUS OF

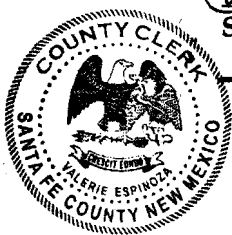

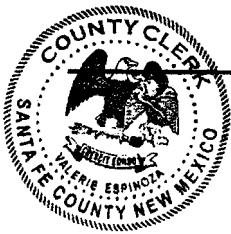

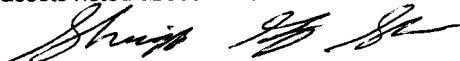
