# A RESOLUTION DELEGATING AUTHORITY TO THE COUNTY MANAGER TO NEGOTIATE AND EXECUTE ALL DOCUMENTS NECESSARY FOR THE ACQUISITION OF REAL PROPERTY INTERESTS NECESSARY FOR THE CONSTRUCTION OF THE VISTA AURORA SEWER SYSTEM IN THE VILLAGE OF AGUA FRIA

WHEREAS, The Vista Aurora Subdivision has been experiencing sewer system problems for many years; and

WHEREAS, the Santa Fe County Board of County Commissioners ("Board") authorized capital funding to make the sewer system improvements (the "Project"); and

WHEREAS, the Project will tie in to an existing sewer line on Calle Atajo in the Las Acequias Subdivision; and

WHEREAS, the Project will also allow for property owners on Lopez Lane to tie in to the sewer system; and

WHEREAS, the County will need to acquire real property interests from; i) City of Santa Fe, ii) PNM, and iii) properties listed on Exhibit A (collectively "Properties") in order to complete the Project; and

WHEREAS, the Board has appropriated and budgeted funding to acquire any necessary easements to complete the Project.

### NOW, THEREFORE, BE IT RESOLVED by the Board as follows:

- A. The County Manager is authorized to acquire on behalf of the County any easements necessary to complete the Project, either through donation or purchase. Under this authority, the County Manager may negotiate, prepare, and execute agreements and any other documents that may be required or appropriate.
- B. The purchase price of any easement shall not exceed its fair market value, as determined by a certified appraiser. The cumulative acquisition costs shall not exceed the budgeted amount.
