RESOLUTION NO. 2018-37

A RESOLUTION AMENDING RESOLUTION NO. 2018-10 TO ADD TWO NEW CODE ENFORCEMENT OFFICERS TO THE LIST OF STAFF WHO ARE AUTHORIZED TO ISSUE CITATIONS FOR VIOLATIONS OF COUNTY ORDINANCES.

WHEREAS, pursuant to NMSA 1978, Section 4-37-3 (1993), County Ordinances may be enforced by prosecution for violations of such Ordinances in any Court of competent jurisdiction of the County;

WHEREAS, pursuant to NMSA 1978, Section 4-37-3 (B) (1993), citations for violations of County Ordinances may be commenced by the issuance of a citation charging the violation;

WHEREAS, pursuant to NMSA 1978, Section 4-37-3 (B) (1993), citations may be issued by County Code Enforcement Officers or other County employees who are authorized by the Board of County Commissioners to issue citations; and

WHEREAS, Santa Fe County will uphold County Ordinances by having Code Enforcement Officers tasked with issuing citations for violations to ensure compliance;

WHEREAS, pursuant to Ordinance 2016-9, the Sustainable Land Development Code, the Board shall annually appoint persons to serve as code enforcement officers and who will be primarily responsible for enforcement of the SLDC; and

WHEREAS, by Resolution No. 2018-10, the Santa Fe County Board of County Commissioners (BCC) appointed and commissioned the following Code Enforcement Officers to issue citations for violations of County ordinances:

- John Lovato
- Rick Lovato
- Arthur "Gene" Portillo
- Paul Kavanaugh
- Joe Martinez; and

WHEREAS, the County has since hired two additional Code Enforcement Officers who need to be appointed and commissioned to issue citations for violations of County ordinances.

NOW, THEREFORE, BE IT RESOLVED by the BCC that the following County employees are added to paragraph C of Resolution 2018-10, which contains the list of officers authorized and commissioned to issue citations charging violations of County Ordinances contained in:

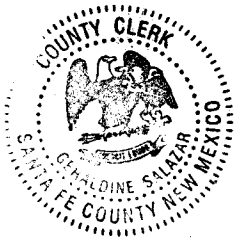
