RESOLUTION NO. 2018 - 87**

**A RESOLUTION DESIGNATING THE PORTION OF HENRY LYNCH
ROAD LOCATED WITHIN COMMISSION DISTRICT 2, OUTSIDE THE
INCORPORATED CITY OF SANTA FE, A COUNTY-MAINTAINED
ROAD**

Whereas, pursuant to NMSA 1978, Section 67-2-1, "All public highways, except such as are owned and operated by private corporations, and highways within the corporate limits of any incorporated city or town, shall be maintained and kept in repair by the respective counties in which they are located", and

Whereas, Henry Lynch Road, identified as the "Proposed Road Segment" on Exhibit A to this Resolution, is an existing public road located within Santa Fe County (County); and

Whereas, as shown on Exhibit A, Henry Lynch Road is partially located within the Village of Agua Fria Traditional Historic Community outside the incorporated City of Santa Fe (City), referred herein to as the "City Section", and partially located within the unincorporated County, referred to as the "County Section"; and

Whereas, the City only maintains the City Section of Henry Lynch Road; and

Whereas, pursuant to the policy adopted by Resolution No. 2012-151, the Board of County Commissioners (Board) desires to formerly designate the County Section of Henry Lynch Road as a County-maintained road; and

Whereas, the County Section of Henry Lynch Road is paved with asphalt, 22-feet wide, and begins at the intersection of Agua Fria Street and ends at the incorporated City limits, a distance of 720 feet, as shown on the attached Exhibit A.

NOW, THEREFORE, BE IT RESOLVED that the Board hereby designates the County Section of Henry Lynch Road a County-maintained road.

BE IT FURTHER RESOLVED that the County Portion of Henry Lynch Road shall be added to the certified listing of County-Maintained Roads filed with the New Mexico Department of Transportation.

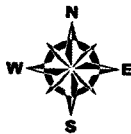

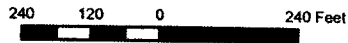
