A RESOLUTION AUTHORIZING THE COUNTY MANAGER TO  
APPROVE AND SIGN PURCHASE ORDERS FOR VEHICLE FUEL  
PURCHASES AND LANDFILL TIPPING FEES FOR THE FLEET  
MANAGEMENT AND SOLID WASTE DEPARTMENTS

**WHEREAS**, the Santa Fe County ("County") Fleet Management Department is responsible for purchasing fuel, unleaded and diesel for all vehicles and equipment owned and maintained by the County; and

**WHEREAS**, the County Solid Waste Department is responsible for overseeing and managing the disposal of solid waste (trash) within the County, including the disposal of solid waste at designated landfills within the County; and

**WHEREAS**, on an annual basis the Fleet Management Department's vehicle and fuel expenses exceed \$650,000 and the Solid Waste Management Department's tipping fees exceed \$600,000; and

**WHEREAS**, in order to facilitate the efficient day-to-day operation of the Fleet Management and Solid Waste Departments' operations and pursuant to Section 2(c) of Resolution No. 2014-143,, the Board of County Commissioners ("Board") wishes to delegate approval and signatory authority to the County Manager for purchase orders for fuel for the Fleet Management Department and for tipping fees for the Solid Waste Department.

**NOW, THEREFORE, BE IT RESOLVED** by the Board as follows:

1. The County Manager is hereby delegated the authority to approve and sign purchase orders for fuel purchases for the Fleet Management Department.
2. The County Manager is hereby delegated the authority to approve and sign purchase orders for tipping fees for the Solid Waste Department.

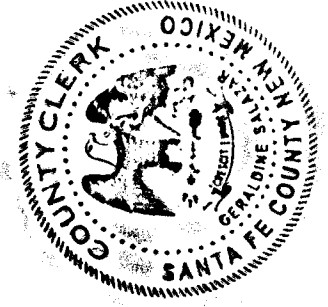

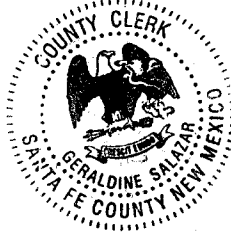
