**A RESOLUTION DESIGNATING OFFICIAL  
REPRESENTATIVES FOR GRANT 19-D2539-GF FOR THE  
CHUPADERO WATER SYSTEM IMPROVEMENTS AND  
REQUESTING THE BOARD OF COUNTY COMMISSIONERS  
TO SIGN THE GRANT AGREEMENT**

**WHEREAS**, in 2019, the State of New Mexico passed Senate Bill 280 for Capital Outlay; and

**WHEREAS**, Senate Bill 280 is now Chapter 277 of the Laws of 2019; and

**WHEREAS**, Section 26, Paragraph 112 of Chapter 277 of the Laws of 2019 authorized the Department of Environment of the State of New Mexico to issue grant funding in the amount of \$110,000 to plan, design and construct improvements to the water system for the Chupadero-water-sewage corporation in Santa Fe County; and

**WHEREAS**, Santa Fe County wishes to accept and execute Grant #19-D2539-GF; and

**WHEREAS**, the Department of Environment of the State of New Mexico requires official representatives for Santa Fe County be designated via Resolution.

**NOW, THEREFORE, BE IT RESOLVED**, the Board of County Commissioners hereby executes Grant #19-D2539-GF and designates Gary L. J. Giron, Finance Division Director, as official representative and Yvonne Herrera, Accounting and Financial Reporting Manger, as alternate official representative concerning all matters related to this grant agreement for Santa Fe County.

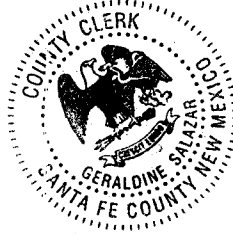
