A RESOLUTION ACCEPTING THE 2019-2020 WILDFIRE RISK REDUCTION  
GRANT FROM THE NEW MEXICO ASSOCIATION OF COUNTIES, AND  
ACKNOWLEDGMENT AND ACCEPTANCE OF THE GRANT TERMS AND  
CONDITIONS

WHEREAS, Santa Fe County Fire Department was selected as a recipient of the 2019-2020 Wildfire Risk Reduction Program Grant for a project titled "Santa Fe County Community Wildfire Protection Plan Update" in the amount of \$15,000; and

WHEREAS, the Santa Fe County Fire Department will procure the services of a contractor to update the County's 2008 Community Wildfire Protection Plan (CWPP) as detailed in the Healthy Forests Restoration Act (HFRA 2003). A current CWPP is an essential tool for addressing the issues regarding deteriorating forest health and the need for greater community protection from wildfire in urban interface areas; and

WHEREAS, as a condition of receipt of these grant funds, Santa Fe County is required to return the executed Grant Acknowledgement Form and a signed resolution confirming that the County has read, understands, and will comply with the terms and conditions of the Wildfire Risk Reduction Program Grant; and

NOW, THEREFORE, BE IT RESOLVED, that the Santa Fe County Board of Commissioners confirms that it has read, understands, and will comply with the terms and conditions of the Wildfire Risk Reduction Program Grant.

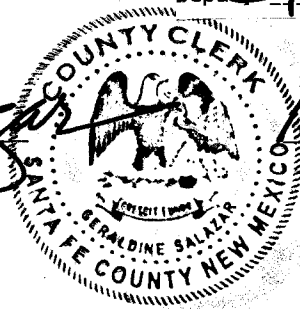
