**A RESOLUTION AUTHORIZING THE DISPOSITION OF
FIXED ASSETS VALUED AT LESS THAN \$5,000
IN ACCORDANCE WITH STATE STATUTE**

WHEREAS, Santa Fe County ("County") desires to dispose of certain items of personal property identified in Exhibit A; and

WHEREAS, Exhibit A describes each item of personal property by department, tag number, description of fixed asset, and serial number; and

WHEREAS, the County desires to recycle the personal property; and

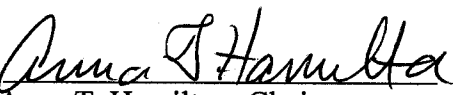
WHEREAS, the Board of County Commissioners ("Board") hereby determines that each item of personal property has an estimated current resale value of less than \$5,000.

NOW, THEREFORE, BE IT RESOLVED by the Board:

1. The Board approves of the disposition of the items of personal property in accordance with NMSA 1978, Section 13-6-1 (2013); and
2. The Board directs that, to the extent feasible, all the items of personal property shall be recycled. If recycling is determined not to be feasible the items shall be disposed of in accordance with state statute.

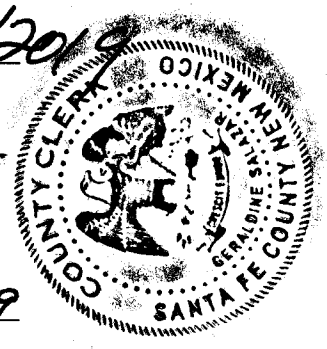
