**A RESOLUTION AUTHORIZING THE DISPOSITION OF
FIXED ASSETS WORTH \$5,000 OR LESS
IN ACCORDANCE WITH STATE STATUTE**

WHEREAS, Santa Fe County ("County") desires to dispose of certain personal property identified in Exhibit A; and

WHEREAS, Exhibit A describes each item of personal property by department, tag number, description of fixed asset, and serial number; and

WHEREAS, the County desires to donate these items of personal property to the New Mexico Department of Public Safety; and

WHEREAS, the Board of County Commissioners ("Board") hereby determines that each item has an estimated current resale value of \$5,000 or less.

NOW, THEREFORE, BE IT RESOLVED by the Board:

1. The Board approves of the donation of the items of personal property in accordance with NMSA 1978, Section 13-6-2; and
2. The Board directs that, to the extent feasible, all the items of personal property be donated to the New Mexico Department of Public Safety. If such donation is not feasible the items of personal property it shall be disposed of in accordance with state statute.

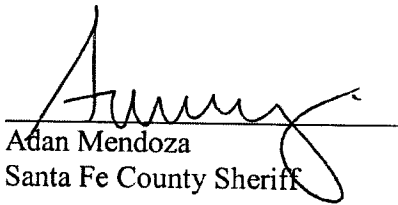
