**A RESOLUTION AUTHORIZING DISPOSITION OF FIXED ASSET WORTH  
MORE THAN \$5,000 IN ACCORDANCE WITH STATE STATUTE**

---

**WHEREAS**, Santa Fe County (County) currently owns certain personal property in the form of a 2009 GMC 5500 Van modified to serve as a mobile health van (Mobile Health Van), listed and identified more specifically on Exhibit A attached hereto; and

**WHEREAS**, from 2009-2018 the Santa Fe County Community Services Department utilized the Mobile Health Van for preventive care, including cholesterol checks, blood pressure, heart rate checks and flu shot; and

**WHEREAS**, the passage of the Affordable Care Act expanded health insurance in a manner that allows for expanded health care coverage for indigent clients; and

**WHEREAS**, the Santa Fe County Community Services Department has determined that the Mobile Health Van is no longer compatible with the priorities for the Community Services Department as outlined in the Health Action Plan; and

**WHEREAS**, in 2017 the Gap Analysis completed by the County recommended developing free standing navigators who can provide services at a community level;

**WHEREAS**, the County has invested in the development of Santa Fe County Connect, an Accountable Health Community which emphasizes navigation services as a tool to address the Social Determinants of Health; and

**WHEREAS**, the County has developed services that will be better focused on County health care needs and will be funded and provided for at less cost to the County; and

**WHEREAS**, the Board of County Commissioners (BCC) hereby determines that Mobile Health Van identified in Exhibit A (i) is no longer economical for continued use by the County, and (ii) has an estimated current resale value of five thousand dollars (\$5,000) or more; and

**WHEREAS**, the County has leased the Mobile Health Van to the New Mexico Department of Health (NMDOH) since February 22, 2019 under Agreement No. 2019-0248-CSD/BT (Vehicle Lease), and that Vehicle Lease, as amended, is due to expire on December 31, 2019; and

**WHEREAS**, NMDOH desires to purchase the Mobile Health Van from the County at the end of the Vehicle Lease for a price negotiated between the County and NMDOH; and

WHEREAS, the County wishes to use funds derived from the sale of the Mobile Health Van in the County Community Services Department to fund the Santa Fe County Connect program.

NOW, THEREFORE, BE IT RESOLVED that the BCC (i) approves of the disposal through sale of the personal property listed on Exhibit A pursuant to NMSA 1978, Section 13-6-1 (2013) and Section 13-6-2 (2007), and (ii) directs that, to the extent feasible, the personal property listed on Exhibit A be sold at a negotiated price to the New Mexico Department of Health, but if that is not feasible, it shall be disposed of as otherwise allowed by law.

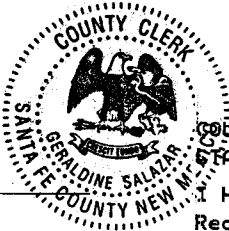
