## A RESOLUTION

AUTHORIZING THE COUNTY MANAGER TO OBTAIN EXTENSIONS FROM THE PUEBLOS OF NAMBE, POJOAQUE, SAN ILDEFONSO, AND TESUQUE OF DEADLINES UNDER THE RESPECTIVE SETTLEMENT AGREEMENTS WITH THOSE PUEBLOS CONCERNING COUNTY-MAINTAINED ROADS

WHEREAS, Santa Fe County (County) is party to certain Settlement Agreements by and between the County, the United States Department of the Interior, and each of the Pueblos of Nambe, Pojoaque, San Ildefonso, and Tesuque (collectively, the Settlement Agreements) concerning certain county-maintained roads (CMRs) within each Pueblo; and

WHEREAS, the Settlement Agreements contain certain deadlines that may be extended by agreement of the parties, such as deadlines for the submission of rights-of-way (ROW) applications to the Bureau of Indian Affairs (BIA) for the CMRs, and the construction of new roads; and

WHEREAS, the County has retained a qualified surveyor to, among other things, conduct the surveying necessary for the ROW applications and to prepare the necessary applications; and

WHEREAS, despite diligent efforts by the surveyor and in light of the fact that the parties to the Settlement Agreements were focused on other projects of mutual benefit and interest, the existing deadlines under some or all of the Settlement Agreements may not be met; and

WHEREAS, the Board desires to authorize the County Manager to seek, negotiate, document, and execute (if necessary) agreements related to extensions of applicable deadlines under the Settlement Agreements.

NOW, THEREFORE, BE IT RESOLVED that the Board hereby delegates to the County Manager the authority to seek, negotiate, document, and execute (if necessary) agreements related to extensions of applicable deadlines under the Settlement Agreements.
