**A RESOLUTION AUTHORIZING THE DISPOSITION OF
FIXED ASSETS WORTH MORE THAN \$5,000
IN ACCORDANCE WITH STATE STATUTE**

WHEREAS, Santa Fe County ("County") desires to dispose of certain personal property identified in Exhibit A; and

WHEREAS, Exhibit A describes an item of personal property by department, tag number, description of fixed asset, and serial number; and

WHEREAS, the County desires to donate the item of personal property listed on Exhibit A to the Cabo Lucero Fire Department in San Miguel County; and

WHEREAS, the Board of County Commissioners ("Board") hereby determines that the item of personal property listed on Exhibit A has an estimated resale value of more than \$5,000.

NOW, THEREFORE, BE IT RESOLVED by the Board as follows:

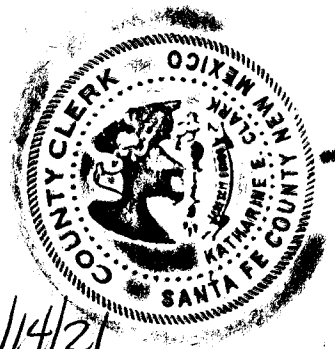
1. The Board approves of the donation of the item of personal property listed on Exhibit A in accordance with NMSA 1978, Section 13-6-2 (2013); and

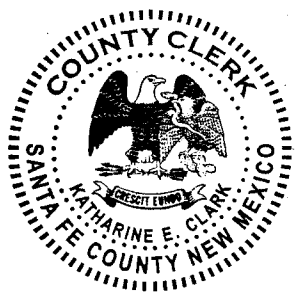
