A RESOLUTION ADOPTING LOCAL GOVERNMENTS ROAD IMPROVEMENT FUND PROJECT NO. SP-L500350 FOR PAVEMENT REHABILITATION/IMPROVEMENTS OF SANTUARIO DRIVE (CR 94C) AND MARTIN ROAD (CR 17)

WHEREAS, pursuant to NMSA 1978, Section 67-3-28.2 (Local governments road fund created; uses), assistance for local road construction and repair is available through the New Mexico Department of Transportation (NMDOT) from the Local Governments Road Improvements Fund (LGRF); and

WHEREAS, the County of Santa Fe (County) applied for fiscal year 2020 LGRF funding for pavement rehabilitation/improvements on various roads within the County; and

WHEREAS, by letter dated May 29, 2019, NMDOT informed the County that Project No. SP-L500350 (the Project) is approved; and

WHEREAS, prior to development of a Cooperative Agreement for the Project, NMDOT the Santa Fe Board of County Commissioners (Board) adopted Resolution No. 2019-90 on July 10, 2019, (see Exhibit A) adopting the Project and verifying its priority status; and

WHEREAS, in resolution No. 2020-96, the Board previously adopted an extension of the December 30, 2020, deadline to the December 30, 2021. The completion of the project is contingent upon obtaining the materials that are in short supply due to the COVID-19 virus pandemic. The surrounding plants cannot produce enough product or materials to supply the County and the State of New Mexico; and

WHEREAS, in accordance with the extension adopted in Resolution No. 2020-96, NMDOT has drafted a new Local Government Road Fund Cooperative Agreement (2021 Cooperative Agreement) with a term that expires on December 30, 2021, and requested that the Board re-adopt the Project; and

WHEREAS, the location and other information concerning the Project is depicted on the attached map (see Exhibits B and C) and in the following table:


