A RESOLUTION ESTABLISHING PROCEDURES FOR THE ORDERLY AND
UNIFORM ADMINISTRATION OF THE SANTA FE COUNTY PROCESS FOR ROAD
IMPROVEMENTS

WHEREAS, Santa Fe County encompasses a geographical area of approximately 2,000 square miles; and

WHEREAS, the County is primarily rural with small areas of concentrated development; and

WHEREAS, a comprehensive road system is a necessary and a vital link between communities; and

WHEREAS, there are an estimated 1,500 total miles of roads within the County; and

WHEREAS, the total miles, approximately 555.21 miles are recognized as County roads and maintained by the County; and

WHEREAS, the total miles of improved roadway surface is approximately 290 miles, with a remainder of approximately 265.21 miles unimproved; and

WHEREAS, the citizens of Santa Fe County continuously request the County to improve road surface conditions on County roads; and

WHEREAS, the County's goal is to provide a means for prioritizing road improvement requests from County residents, while being transparent and cognizant of available funding needed to construct these improvements; and

WHEREAS, the Board of County Commissioners desires to have a policy that will consider roadway improvements for County Roads that could benefit from improved driving surfaces.

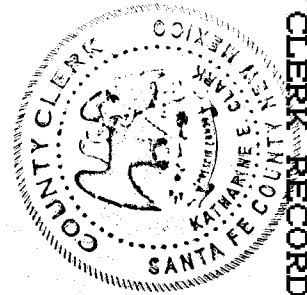

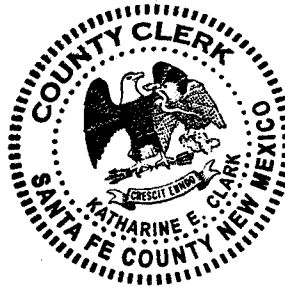
