RESOLUTION NO. 2021 080

**A RESOLUTION ADOPTING LOCAL GOVERNMENTS ROAD
IMPROVEMENT FUND PROJECT NO. CAP-L500457 FOR PAVEMENT
REHABILITATION/IMPROVEMENTS OF THANPI TSIDE P'OE (119 N),
CROSS RANCH ROAD (15), JAYMAR ROAD (16A), CAMINO CABREROS,
CALLE LOMITA, JUEGO ROAD, JUEGO COURT AND GLORIETA ROAD**

WHEREAS, pursuant to NMSA 1978, Section 67-3-28.2 (Local governments road fund created; uses), assistance for local road construction and repair is available through the New Mexico Department of Transportation (NMDOT) from the Local Governments Road Improvements Fund (LGRF); and

WHEREAS, the County of Santa Fe (County) applied for fiscal year 2022 LGRF funding for pavement rehabilitation/improvements on various roads within the County; and

WHEREAS, by letter dated June 1, 2021 (see Exhibit A), NMDOT informed the County that Project No. CAP-L500457 (the Project) is approved; and

WHEREAS, prior to development of a Cooperative Agreement for the Project, NMDOT requires the Santa Fe Board of County Commissioners (Board) to adopt a resolution adopting the Project and verifying its priority status; and

WHEREAS, the Santa Fe County Public Works Department revised the initial list of preservation projects to meet the funding amount awarded by NMDOT; and

WHEREAS, the location and other information concerning the Project is depicted on the attached map (see Exhibit B) and in the following table:



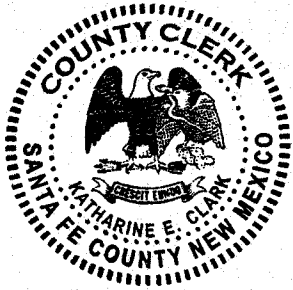
