**A RESOLUTION AFFIRMING SANTA FE COUNTY'S SUPPORT FOR THE NEW
MEXICO SAFE HAVEN FOR INFANTS ACT, IN ORDER TO PROTECT INNOCENT
LIFE**

WHEREAS, the New Mexico State Legislature first adopted the Safe Haven for Infants Act ("The Act") in 2005, NMSA 1978, § 2-22-1 et seq.; and

WHEREAS, the Act seeks to promote the safety of infants and to immunize parents from criminal prosecution for leaving an infant, ninety days of age or less, at a safe haven site; and

WHEREAS, Santa Fe County fully supports the legislative intent and practice of the Act and commits itself to participate as intended by law.

NOW, THEREFORE, BE IT RESOLVED that the Board of County Commissioners of Santa Fe County, hereby affirms and commits itself to expanding public awareness of New Mexico's Safe Haven for Infants Act and to provide training to ensure compliance with the Act.

BE IT FURTHER RESOLVED THAT Santa Fe County affirms and commits itself to raising awareness regarding safe haven sites within Santa Fe County, including the following twenty-four (24) hour Santa Fe County Fire Department locations, where parents may leave an infant, ninety days of age or less without criminal prosecution:
