RESOLUTION NO. 2021 013

**A RESOLUTION ADOPTING LOCAL GOVERNMENTS ROAD
IMPROVEMENT FUND PROJECT NO. SB-L500413 FOR PAVEMENT
REHABILITATION/IMPROVEMENTS OF AGUA FRIA ROAD (CR66)**

WHEREAS, pursuant to NMSA 1978, Section 67-3-28.2 (Local governments road fund created; uses), assistance for local road construction and repair is available through the New Mexico Department of Transportation (NMDOT) from the Local Governments Road Improvements Fund (LGRF); and

WHEREAS, the County of Santa Fe (County) applied for fiscal year 2021 LGRF funding for pavement rehabilitation/improvements on various roads within the County; and

WHEREAS, by letter dated May 28, 2020, NMDOT informed the County that Project No. SB-L500413 (the Project) is approved; and

WHEREAS, prior to development of a Cooperative Agreement for the Project, NMDOT the Santa Fe Board of County Commissioners (Board) adopted Resolution No. 2020-85 on November 10, 2020, adopting the Project and verifying its priority standing; and

WHEREAS, the Cooperative Agreement requires the Project be completed by December 30, 2021; and

WHEREAS, the project has been delayed by supply disruptions due the COVID-19 virus pandemic. Suppliers cannot produce enough product or materials to supply the County and the State of New Mexico, therefore Public Works Department requests an extension of the deadline to December 30, 2022; and

WHEREAS, the location and other information concerning the Project is depicted in the following table:
