RESOLUTION NO. 2022 018

**A RESOLUTION
AMENDING RESOLUTION NO. 2021-071 TO DESIGNATE A NEW POLLING PLACE/VOTER
CONVENIENCE CENTER FOR CONSOLIDATED PRECINCTS 14, 72, 88, 114, 126, AND 150 AND
RECONSOLIDATE PRECINCTS 26,74, AND 109**

WHEREAS, on July 27, 2021, the Santa Fe County (County) Board of County Commissioners (Board) adopted Resolution No. 2021-071, which (1) designated polling places in each precinct in the County for 2022 and 2023, (2) consolidated precincts, and (3) divided or adjusted boundaries of certain precincts pursuant to NMSA 1978, Sections 1-3-1, 1-3-4 and 1-3-5; and

WHEREAS, the County Clerk's Office has been informed that the Los Cerrillos Community Center and/or Los Cerrillos Fire Station will not be constructed in time for the 2022 election held on June 7, 2022; and

WHEREAS, Santa Fe County has agreed to allow the County Clerk to utilize the Madrid Fire Station # 1, 5 Firehouse LN, Madrid, NM, as a polling place/voter convenience center for consolidated Precincts 14, 72, 88, 114, 126, and 150; and

WHEREAS, in addition to the Turquoise Trail Charter Elementary School, the Madrid Fire Station #1 is the most convenient and suitable public building in the precinct that can be obtained for use as a polling place/voter convenience center; and

WHEREAS, pursuant to NMSA 1978, Section 1-3-4 (B), no consolidated precinct voting location shall have more than 10 precincts, and 2021-071 has more than ten for three separate polling locations, Santa Fe County Fair Building, Nino Otero Community School, and Gonzales Community School; and

WHEREAS, pursuant to NMSA 1978, Section 1-3-5(B), no precinct shall be created, divided, abolished or combined or the boundaries adjusted less than four months prior to a statewide election, except by order of the district court; and

WHEREAS, contingent upon District Court approval, the Board wishes to amend Resolution No. 2021-071, in order to add the Madrid Fire Station # 1, 5 Firehouse LN, Madrid, NM, as a polling place/voter convenience centers for consolidated Precincts 14, 72, 88, 114, 126, and 150.

NOW, THEREFORE, BE IT RESOLVED that, contingent upon District Court approval, the Board amends Resolution No. 2021-071 as follows:

1. The list of Voting Convenience Centers within a consolidated precinct is amended to add "Madrid Fire Station # 1, 5 Firehouse LN, Madrid, NM" as a Polling Place/Voter Convenience Center for consolidated Precincts 14, 72, 88, 114, 126, and 150.
2. Precinct 26 is moved from the list of precincts for Gonzales Community School to the list of precincts for nearby Montezuma Lodge. Precincts consolidated for Gonzales Community School shall now be 11, 24, 25, 27, 33, 92, 130, 155, 159, and 160; Precincts consolidated for Montezuma Lodge shall now be 10, 22, 26, 28, 30, 91, 122, 123, and 131.
3. Precinct 74 is moved from the list of precincts for the Santa Fe County Fair Building to the list of precincts for nearby Chaparral Elementary School. Precincts consolidated for the Santa Fe County Fair Building shall now be 29, 38, 39, 49, 56, 96, 99, 105, 133, and 173; Precincts consolidated for Chaparral Elementary School shall now be 35, 50, 51, 74, 76, 77, 117, and 124.
4. Precinct 109 is moved from the list of precincts for the Nina Otero Community School/Southside Library to the list of precincts for nearby El Camino Real Academy. Precincts consolidated for the Nina Otero Community School shall now be 64, 67, 75, 106, 116, 137, 138, 140, 141, and 174; Precincts consolidated for El Camino Real Academy shall now be 66, 80, 108, 109, 135, 136, and 145.

NOW, THEREFORE BE IT FURTHER RESOLVED that, following adoption of this Resolution by the Board, pursuant to NMSA 1978, Section 1-11-11, the polling locations listed in this resolution shall make a secure onsite location available to store election day polling equipment at least the Saturday before election day and allow the Clerk or Clerk's staff access and adequate lead time to set up polling locations ahead of Election Day; and

NOW, THEREFORE, BE IT FURTHER RESOLVED that, following adoption of this Resolution by the Board, the County Attorney shall seek approval of the District Court of the new polling place/voter convenience center designation and consolidation set forth above; and

NOW, THEREFORE, BE IT FURTHER RESOLVED that the County Clerk shall forward a copy of this Resolution to the Secretary of State and inform the Secretary of State when the District Court has approved the new polling place/voter convenience designation.
