**A RESOLUTION AUTHORIZING THE DISPOSITION OF FIXED ASSETS WORTH MORE THAN \$5,000 IN ACCORDANCE WITH STATE STATUTE**

**WHEREAS**, Santa Fe County (County) desires to dispose certain personal property identified in Exhibit A; and

**WHEREAS**, Exhibit A details each item of personal property by department or office, tag number, description of fixed asset, serial number, reason for surplus, condition of fixed asset, location of fixed asset, and/or estimated value; and


**WHEREAS**, the Board of County Commissioners (BCC) hereby determines that: (i) each item of personal property on Exhibit A is worn-out, unusable, or obsolete to the extent that the item is no longer economical or safe for continued use by the County, and (ii) each item on Exhibit A has an estimated current resale value of more than five thousand dollars (\$5,000).

**NOW, THEREFORE, BE IT RESOLVED** that the BCC (i) approves of the disposal of the personal property listed on Exhibit A pursuant to NMSA 1978, Section 13-6-2, and (ii) directs that, to the extent feasible, the personal property shall be sold at public auction and, if that it is not feasible, that it be disposed of as otherwise allowed by law.


