A RESOLUTION IDENTIFYING SANTA FE COUNTY 2023 LEGISLATIVE PRIORITIES FOR AFFORDABLE HOUSING

WHEREAS, legislative pre-filing for the 2023 Regular Legislative Session will occur between January 3, 2023, and January 13, 2023; and

WHEREAS, the Santa Fe County (County) Board of County Commissioners (Board) discusses and approves support for legislative priorities as an important step in assuring the preservation and provision of exemplary services and policies; and

WHEREAS, it is important that the Board take action to maintain revenues, programs, and services at the current or a higher level; and

WHEREAS, the Board would like to demonstrate strong support to the state legislature for legislation accomplishing the following in affordable housing:

- 1. Santa Fe County Public Housing Upgrades Including but not limited to:
 - Roofs
 - Stucco
 - Landscaping
 - Infrastructure
- 2. Nueva Acequia
 - Roads and infrastructure
 - Solar Array
 - Water Recycling System
- 3. Reform of the Property Tax Appreciation Schedule Relative to apartment complexes and second homes
- 4. Funding the New Mexico Housing Trust Fund (NMHTF)
- 5. Support the Santa Fe County Affordable Housing Trust Fund for at least \$200,000
- 6. Support funding for Affordable Housing Act Oversight Duties for at least \$250,000
- 7. Support increase in funding for the State Linkages Program by \$5 million
- 8. To increase funding for the state homeless fund by \$5 million
- 9. Support Legislation for Non Discrimination for Funding Source for rentals
- 10. Support allocation to New Mexico Housing Trust Fund (NMHTF)

NOW, THEREFORE, BE IT RESOLVED that the Board of County Commissioners of Santa Fe County hereby supports the legislative priorities for affordable housing as set forth above, and urges that legislation incorporating these priorities be enacted by the state legislature during its 2023 session.
