**A RESOLUTION AUTHORIZING THE COUNTY MANAGER TO WAIVE THREE (3)
DAY'S RENTAL FEES FOR THE SANTA FE COUNTY FAIRGROUNDS AND
NEGOTIATE A TEMPORARY USE LEASE AGREEMENT WITH PARALLEL
STUDIOS FOR AN EVENT TO BE HELD JUNE 16-25, 2023**

WHEREAS, the CURRENT New Media Festival, which is produced by Parallel Studios, will be hosting its annual event from June 16, 2023 through June 25, 2023; and

WHEREAS, the festival brings together artists and visitors from around the world to celebrate 21st century art making and blends interactive experiences with beauty and wonder; and

WHEREAS, fifty (50) to sixty (60) artists from New Mexico, across the United States, and countries around the world will present works in Installations (interactive and non-interactive), Outdoor Installations and Projections, Experimental Single Channel Video/Experimental Documentary/Animation, Virtual Augmented/Mixed-Reality Environments, AI Generated or Assisted 2D and 3D work, Robotics/Kinetic/Electro-Mechanical Objects and Installations, Multimedia Performance, Digitally Generated or Fabricated Objects, and Wearables; and

WHEREAS, this year, Parallel Studios has once again requested to rent three buildings at the Santa Fe County Fairgrounds for this event; and

WHEREAS, in 2022 there was a conflict between the agreements with the Folk Art Flea and Parallel Studios; and

WHEREAS, both vendors are regular and satisfied users of the Santa Fe County Fairgrounds; and

WHEREAS, Parallel Studios and Folk Art Flea found a solution that was reasonable and allowed both parties to plan and carry out events in 2022; and

WHEREAS, Folk Art Flea was provided fee waived day(s) pursuant to Resolution 2022-25 as part of the agreement to resolve the double booking; and

WHEREAS, Parallel Studios will also be provided fee waived days to provide consideration for the County's double booking; and

WHEREAS in Resolution No. 2015-103, the Board of County Commissioners (Board) adopted rental fees for the Santa Fe County Fairgrounds; and

WHEREAS, the Board desires to expressly authorize the County Manager to waive three (3) days rental fees for the Santa Fe County Fairgrounds and negotiate a Temporary Use Lease Agreement with Parallel Studios for June 16, 2023 through June 25, 2023.

NOW, THEREFORE, BE IT RESOLVED by the Board as follows:

1. The County Manager is hereby authorized to waive three (3) day's rental fees for Parallel Studios for use of the Santa Fe County Fairgrounds from June 16-25, 2023. To the extent required by the Policies and Procedures for Temporary Use Leasing of the Santa Fe County Fairgrounds, the Santa Fe County Fairground Rental Fees adopted by Resolution 2015-103 are hereby amended to allow for this one-time waiver.
2. The County Manager is delegated the authority to negotiate and execute a Temporary Use Lease Agreement with Parallel Studios to occupy this space for the three-day event.

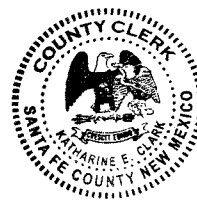
