A RESOLUTION AUTHORIZING THE DISPOSITION OF FIXED ASSETS WORTH MORE THAN \$5,000 IN ACCORDANCE WITH STATE STATUTE

WHEREAS, Santa Fe County ("County") desires to dispose of certain tangible personal property identified in Exhibit A; and

WHEREAS, Exhibit A details items of tangible personal property by department or office, tag number, description of fixed asset, vehicle identification number or serial number, reason for surplus condition of fixed asset, location of fixed asset, and estimated value; and

WHEREAS, NMSA 1978, Section 13-6-2 governs the disposition of tangible personal property belonging to a local public body and allows the disposition of such property worth more than \$5,000; and the such pro

WHEREAS, the Board of County Commissioners ("Board") hereby determines that those items listed in Exhibit A with estimated values of more than five thousand dollars (\$5,000) (i) are worn-out unusable, or obsolete to the extent that the item is no longer economical or safe for continued use by the County, and (ii) have an estimated current resale value of more than five thousand dollars (\$5,000).

NOW, THEREFORE, BE IT RESOLVED by the Board as follows:

- 1. The Board approves of the disposal of the tangible personal property listed on Exhibit A with estimated values of more than five thousand dollars (\$5,000) in accordance with NMSA 1978 Section 13-6-2.
- 2. The Board directs that, to the extent feasible, the tangible personal property shall be sold and public auction and, if that it is not feasible, that it be disposed of as otherwise allowed by lawn
