**A RESOLUTION ADOPTING LOCAL GOVERNMENTS ROAD  
IMPROVEMENT FUND PROJECT NO. CAP-L500512 FOR PAVEMENT  
REHABILITATION/IMPROVEMENTS OF QUIET VALLEY LOOP AND  
QUIET VALLEY CIRCLE**

**WHEREAS**, pursuant to NMSA 1978, Section 67-3-28.2 (Local governments road fund created; uses), assistance for local road construction and repair is available through the New Mexico Department of Transportation (NMDOT) from the Local Governments Road Improvements Fund (LGRF); and

**WHEREAS**, the County of Santa Fe (County) applied for fiscal year 2022 LGRF funding for pavement rehabilitation/improvements on various roads within the County; and

**WHEREAS**, by letter dated June 1, 2022, NMDOT informed the County that Project No. CAP-L500512 (the Project) is approved; and

**WHEREAS**, prior to development of a Cooperative Agreement for the Project with NMDOT, the Santa Fe Board of County Commissioners (Board) adopted Resolution No. 2022-085 on October 25, 2022, (see Exhibit A) adopting the Project and verifying its priority status; and

**WHEREAS**, the County Public Works Department is requesting an extension of the December 31, 2023, deadline to the December 31, 2024. The completion of the project was delayed due to staffing shortages in the Road Maintenance Section within the Public Works Department; and

**WHEREAS**, the location and other information concerning the Project is depicted on the attached map (see exhibit B) and in the following table:
