A RESOLUTION

AUTHORIZING THE COUNTY MANAGER TO SECURE MULTI-LINE, LAW ENFORCEMENT, AND OTHER INSURANCE COVERAGES FOR CALENDAR YEAR 2024; TO FINALIZE NEGOTIATIONS FOR SUCH COVERAGES; AND TO EXECUTE ALL DOCUMENTS NECESSARY TO EFFECTUATE SUCH COVERAGES

WHEREAS, Santa Fe County (County) solicited proposals for multi-line, law enforcement, and other insurance coverages for calendar year 2024 from the New Mexico County Insurance Authority (NMCIA); and

WHEREAS, the premiums for such coverages will exceed the County Manager's general signature authority; and

WHEREAS, the Board desires to authorize the County Manager to finalize the details of such coverages with NMCIA for calendar year 2024, including deductibles, negotiate with NMCIA for such coverages, and to execute on behalf of the County all purchase orders, agreements, and other documents necessary or advisable to effectuate such coverages.

NOW, THEREFORE, BE IT RESOLVED that the Board hereby delegates to the County Manager the authority to:

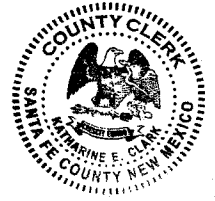
1. Finalize the details of multi-line, law enforcement, and other insurance coverages offered by or through NMCIA for calendar year 2024;
2. Negotiate with NMCIA for such coverages for calendar year 2024; and
3. Execute on behalf of Santa Fe County purchase orders, agreements, and other documents necessary or advisable to effectuate such coverages.
