RESOLUTION NO. 2024 - 039

A RESOLUTION AMENDING RESOLUTION NO. 2022-060, TO AMEND THE DESIGNATION OF THE SECURITY OFFICER, AS THAT TERM IS USED IN THE SANTA FE COUNTY HEALTH INSURANCE PORTABILITY AND ACCOUNTABILITY ACT OF 1996 (HIPAA) POLICIES

WHEREAS, on July 27, 2022, the Board of County Commissioners (Board) of Santa Fe County (County) adopted Resolution No. 2022-060, which recognized Santa Fe County as a hybrid entity in compliance with the Health Insurance Portability and Accountability Act of 1996 (HIPAA), which also repealed Resolution No. 2003-59, and delegated to the County Manager the authority to adopt, revoke, and amend HIPAA policies and procedures; and

WHEREAS, by Resolution No. 2022-060, the Board designated certain employees to serve as the Privacy and Security Officers under HIPAA; and

WHEREAS, the Board now desires to update the Security Officer under HIPAA.

NOW, THEREFORE, BE IT RESOLVED that the Santa Fe County Board of County Commissioners hereby amends Resolution No. 2022-060, by repealing the designation of Security Officer, and replacing that provision with the following:

“The IT Director or its Designee shall be the Security Officer for the County under HIPAA, responsible for the security of patient health information maintained by the health care components of Santa Fe County.”

BE IT FURTHER RESOLVED that all other provisions of Resolution No. 2022-060, not amended by this Resolution, shall remain in full force and effect.
