**A RESOLUTION TO ADOPT THE SANTA FE COUNTY HEALTH ACTION PLAN
FY 2024-2029**

WHEREAS, a healthy community is a primary goal for Santa Fe County (“County”); and

WHEREAS, the role and function of the Health Policy and Planning Commission (“HPPC”) includes serving in an advisory capacity to the Board of County Commissioner (“Board) in recommending health and human services policies and programs to the Board and conducting a county-wide health and human services needs assessment, recommending priorities and evaluating the capacity of the County to address health care and human services needs of the community (Resolution No. 2009-71); and

WHEREAS, the HPPC and the Community Services Department (“CSD”) have actively participated in community health assessments conducted by Christus St. Vincent Hospital and Presbyterian Hospital, and have reviewed other relevant data sources to identify current health care trends; and

WHEREAS, the *Santa Fe County Health Action Plan FY 2015-2017* has been a strong guiding document and robust reference for health priorities for the County and community providers; and

WHEREAS, in 2014, the Board approved the *Santa Fe County Health Action Plan FY 2015-2017* recommended by the HPPC and CSD; and

WHEREAS, the HPPC, in collaboration with CSD and others, have updated the Health Action Plan to incorporate new priority areas based on the review of multiple data sources; and

WHEREAS, the Health Action Plan, developed in alignment with our County Strategic Plan, will be updated with any new activities in Envisio; and

WHEREAS, the HPPC, in collaboration with CSD, identified seven high-priority health goals for the County and the community as a whole to pursue from January 2024 through December 2029; and

WHEREAS, it is imperative that the Board formally adopts the Health Action Plan and any subsequent revisions to ensure its effective implementation; and

WHEREAS, an updated Health Action Plan, proposed to replace the *Santa Fe County Health Action Plan FY 2015-2017*, is attached as Exhibit A to this Resolution.

NOW, THEREFORE, BE IT RESOLVED that the Board of County Commissioners of Santa Fe County hereby adopts the Santa Fe County Health Action Plan FY 2024-2029. This will continue to serve as a guiding document for Santa Fe County and providers community-wide.
