RESOLUTION NO. 2024 - 080

A RESOLUTION AUTHORIZING SANTA FE COUNTY TO PICK-UP SEVENTY-FIVE PERCENT OF THE PERA MUNICIPAL POLICE COVERAGE PLAN 5 MEMBER CONTRIBUTIONS BASED ON THE RATES IN EFFECT ON THE DATE OF ADOPTION OF THIS RESOLUTION

WHEREAS, NMSA 1978, Section 10-11-5, authorizes affiliated public employers to be responsible for making contributions of up to seventy-five percent (75%) of its employees' member contributions to the Public Employees Retirement Association (PERA) under certain conditions; and

WHEREAS, Santa Fe County's (County) NMCP SO/Santa Fe County Deputy Sheriff's Association is comprised of the following positions: Deputy I, Deputy II, Deputy III, Corporal, and Sergeant; and

WHEREAS, in addition to the aforementioned bargaining unit positions, the following positions participate in the PERA Municipal Police Coverage Plan 5: Lieutenant, Captain, Major, Undersheriff and Sheriff; and

WHEREAS, the Santa Fe County Board of County Commissioners (BCC) has included in Section 34 of the collective bargaining agreement between Santa Fe County and NMCP SO/Santa Fe County Deputy Sheriff's Association (CBA), effective July 13, 2024, an employer pick-up of seventy-five percent of employee PERA contributions based on the Municipal Police Coverage Plan 5 contribution rates which go into effect on July 1, 2024; and

WHEREAS, the BCC hereby elects to pick-up seventy-five percent of the employee PERA contributions which go into effect on July 1, 2024, for non-bargaining unit employees participating in PERA's Municipal Police Coverage Plan 5; and

WHEREAS, under this resolution, the employee contribution percentage would be 4.8250% of salary and the employer pick-up of employee contributions would be 14.4750% of the employees' salary; and

WHEREAS, pursuant to NMSA 1978, Section 10-11-5, this Resolution is irrevocable and shall apply to all County employees participating in the Santa Fe County Municipal General Member Coverage Plan 5.

NOW, THEREFORE, BE IT RESOLVED that the BCC, pursuant to NMSA 1978, Section 10-11-5, hereby elects to be responsible for making contributions of seventy-five percent (75%) of employees' total member contributions to PERA for the Municipal Police Coverage Plan 5, based on the contribution rates in effect at the time this resolution is passed, adopted and approved.

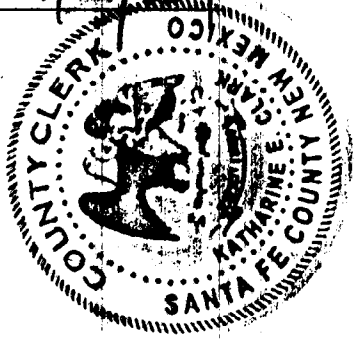
