**A RESOLUTION TO UPDATE MAP 10-1 OF THE SUSTAINABLE GROWTH  
MANAGEMENT PLAN, 'EXISTING TRANSPORTATION SYSTEM,' WITH THE 2024  
FUNCTIONAL CLASSIFICATION OF ROADWAYS SYSTEM MAP**

---

**WHEREAS**, the Santa Fe County Board of County Commissioners (BCC), by Resolution No. 2015-155, adopted the Santa Fe County General Plan, titled 'Sustainable Growth Management Plan (SGMP);' and

**WHEREAS** Map 10-1 of the SGMP, titled 'Existing Transportation System,' was created in May of 2010; and

**WHEREAS**, the New Mexico Department of Transportation (NMDOT) is currently requesting local government updates to the Statewide Functional Classification System Map, which is a Federal Highway Administration (FHWA) requirement every 10 years; and

**WHEREAS**, County staff have prepared an updated, '2024 Santa Fe County Functional Classification of Roadways System Map' for the County Transportation Plan, for NMDOT, and for FHWA, shown as Exhibit 'B'; and

**WHEREAS**, the Santa Fe County Transportation Advisory Committee, at their Sept 11, 2023 meeting, made a recommendation that the BCC approve the updated, 2023 Functional Classification Map.

**NOW, THEREFORE, BE IT RESOLVED** that the Santa Fe County Board of County Commissioners:

1. Hereby adopt the updated '2024 Santa Fe County Functional Classification of Roadways System Map,' to replace Map 10-1 of the SGMP, and
2. Direct staff to submit the '2024 Santa Fe County Functional Classification of Roadways System Map' to NMDOT and FHWA.

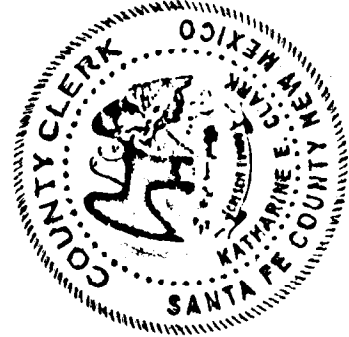
