RESOLUTION NO. 2024 - 148

**A RESOLUTION AUTHORIZING FREE WASTE DISPOSAL VIA ROLL-OFF
DUMPSTERS FOR THE PUEBLO OF TESUQUE DURING CALENDAR YEAR 2024**

WHEREAS, Santa Fe County (County) and the Pueblo of Tesuque (Tesuque) are parties to that certain Solid Waste Transfer Station Permit (Permit), pursuant to which the Pueblo allows the County to operate a solid waste transfer station on Pueblo land in exchange for the County provision of roll-off containers for four (4) special events at the Pueblo and use of northern convenience centers by Pueblo members for free; and

WHEREAS, during calendar year 2024, the Pueblo has requested that the County provide roll-off containers for six (6) special events at the Pueblo and may ask for roll-off containers at additional special events; and

WHEREAS, Santa Fe County Ordinance No. 2014-10, Solid Waste and Recycling Management Ordinance, as amended by Ordinance No. 2022-04, authorizes the Board of County Commissioners to approve free solid waste disposal by agreement or resolution; and

WHEREAS, the Board of County Commissioners desires to accommodate the Pueblo's additional requests during calendar year 2024, since (1) providing roll off containers for Pueblo special events, such as feast days, strengthens intergovernmental relations; (2) the incremental cost to the County of providing roll-off containers at the Pueblo versus having Pueblo members transport solid waste to a transfer station is marginal; and (3) providing roll-off containers at the Pueblo versus having Pueblo members transport solid waste to a transfer station reduces vehicular travel to transfer stations.

NOW, THEREFORE, BE IT RESOLVED by the Santa Fe County Board of County Commissioners that County staff is authorized to provide roll-off dumpsters at the Pueblo for up to an additional four (4) special events at the Pueblo during calendar year 2024, the number and type of roll-off dumpsters to be determined by the Public Works Department Director in their discretion. For the avoidance of doubt, this is in addition to the four (4) special events for which roll-off bins are authorized in the Permit.
