1	<p>Please summarize the request and its purpose in the area below.</p> <p>The Housing Authority administers the FSS Program, for which the U.S. Department of Housing and Urban Development (HUD) provides annual grant allocations. The FSS Program offers self-sufficiency services to Public Housing and Voucher clients. FSS grant funding is specifically used to support the salary and benefit requirements of an FSS Coordinator who oversees the program's operations.</p> <p>On February 28, 2025, the Housing Authority was awarded the 2025 FSS Grant Award (FSS25NM6416) in the amount of \$85,666. This funding is currently allocated in the HUD Line of Credit Control System and is available for drawdown.</p> <p>This funding is for a project period beginning January 1, 2025, through December 31, 2025. The requested amount of \$43,833 is to budget for the remaining period of fiscal year 2025 (January 1, 2025 through June 30, 2025). The remaining \$43,833 has been entered into the fiscal year 2026 budget (July 1, 2025, through December 31, 2025).</p>



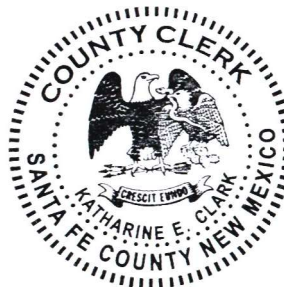
