**A RESOLUTION AUTHORIZING THE COUNTY MANAGER TO COMPLETE AND
SUBMIT COMMUNITY WILDFIRE DEFENSE GRANT (CWDG) PROGRAM
APPLICATIONS AND RELATED DOCUMENTS AND AGREEMENTS**

WHEREAS, Santa Fe County (County) recognizes the importance of wildfire mitigation and planning efforts to enhance the safety and resilience of the County's communities; and

WHEREAS, the Community Wildfire Defense Grant (CWDG) Program provides funding to support wildfire mitigation activities and the development or revision of Community Wildfire Protection Plans (CWPPs); and

WHEREAS, the County is submitting two applications for CWDG funding: one for wildfire mitigation efforts in various areas of the County, and another to support the rewrite of the Santa Fe County Community Wildfire Protection Plan (CWPP); and

WHEREAS, it is necessary to designate an authorized representative to sign and submit the applications and any associated documents on behalf of Santa Fe County to ensure the timely and efficient processing of the grant requests; and

WHEREAS, timely completion and submittal of the grant applications is facilitated by the Board of County Commissioners' (Board) delegation of authority to the County Manager to complete and submit the applications and execute all related documents and agreements, including amendments, as part of the application and grant acceptance process.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners as follows:

1. Santa Fe County shall submit two applications to the Community Wildfire Defense Grant Program to request grant funding: one for wildfire mitigation efforts in various areas of the County, and another to support the rewrite of the Santa Fe County Community Wildfire Protection Plan (CWPP).
2. The Santa Fe County Manager is delegated the authority to complete, sign, and submit the applications to Community Wildfire Defense Grant Program.
3. The County Manager is further delegated the authority to execute all related documentation and agreements, including grant acceptance agreements and amendments, that may be required to complete and accept any grant of funding from the Community Wildfire Defense Grant Program.

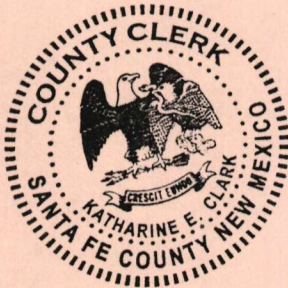
