RESOLUTION NO. 2025 - 038

A RESOLUTION ADOPTING PROJECTS FOR INCLUSION IN SANTA FE COUNTY'S SENIOR SERVICES CAPITAL IMPROVEMENT PLAN FOR FISCAL YEARS 2027-2031; AUTHORIZING SUBMITTAL OF THE PLAN TO THE NEW MEXICO DEPARTMENT OF FINANCE AND ADMINISTRATION; AND REPLACING RESOLUTION NO. 2024-073

WHEREAS, the Board of County Commissioners (Board or BCC) of Santa Fe County recognizes that the financing of public capital projects has become a major concern in New Mexico and nationally; and

WHEREAS, in times of scarce resources, it is necessary to find new financing mechanisms and maximize the use of existing resources; and

WHEREAS, systematic capital improvements planning is an effective tool for communities to determine which projects should be developed, establish priorities, and identify and pursue concrete actions and strategies to achieve necessary projects development; and

WHEREAS, short-and long-range capital planning contributes to local and regional efforts to identify and select projects; and

WHEREAS, a list of projects for inclusion in the County's Infrastructure and Capital Improvement Plan (ICIP) for Fiscal Years (FY) 2027-2031 was developed in a series of community meetings among citizens, staff, and elected officials from various levels of government.


NOW, THEREFORE, BE IT RESOLVED that the Santa Fe County Board of County Commissioners hereby:

1. Adopts the County's FY 2027-2031 ICIP the list of projects that staff presented to the Board at its March 25, 2025, meeting. The list of projects is attached as Exhibit A.
2. Directs staff to submit the ICIP to the New Mexico Department of Finance and Administration, prioritizing such projects in accordance with the Board's comments.
3. Repeals and replaces Resolution No. 2024-073 with this resolution.

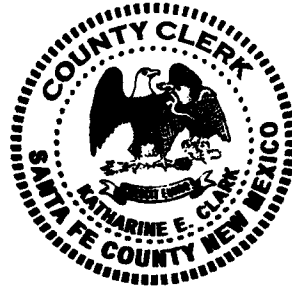
