**A RESOLUTION TO ESTABLISH A COMMUNITY ORGANIZATION FOR  
THE LA CAÑADA DE LOS ALAMOS COMMUNITY**

---

**WHEREAS**, on October 27, 2015, the Board of County Commissioners adopted the Sustainable Growth Management Plan (SGMP) and designated it as the comprehensive plan for Santa Fe County as prescribed by New Mexico law, including but not limited to NMSA 1978, Section 3-21-5; and

**WHEREAS**, the SGMP provides that the County will establish Community Organizations (CO) “for communities and community-oriented organizations to have an improved public participation process to meet community needs and to make recommendations with respect to development projects and community development issues;” and

**WHEREAS**, the SGMP defines a traditional community as “communities where there has been continuous settlement since 1925, a historic pattern of diverse and mixed community land uses which have carried through the present, and presence of historic structures and an existence of a village center. Areas in the County which had already been settled at densities higher than the hydrologic studies and the 1980 General Plan would allow were also designated Traditional Communities;” and

**WHEREAS**, La Cañada de los Alamos is designated as a traditional community in the SGMP; and

**WHEREAS**, on December 13, 2016, the Board of County Commissioners adopted Ordinance No. 2016-9, the Sustainable Land Development Code (SLDC), which governs land use and development throughout the unincorporated areas of the County; and

**WHEREAS**, the SLDC, at Section 2.2.2, establishes the creation of CO’s, identifies the process for BCC recognition of CO’s, and enumerates the rights and responsibilities of CO’s; and

**WHEREAS**, La Cañada de los Alamos Community Association has applied to be recognized as the CO representing the La Cañada de los Alamos community; and

**WHEREAS**, for the purpose of this application, the boundaries of the La Cañada de los Alamos community is defined the same as the U.S. Census Bureau’s boundaries for the Cañada de los Alamos Census-Designated Place (CDP).

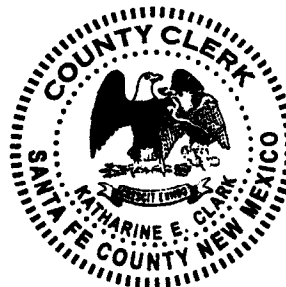
