**A RESOLUTION TO PARTICIPATE IN TRANSPORTATION PROJECT FUND
PROGRAM ADMINISTERED BY NEW MEXICO DEPARTMENT OF
TRANSPORTATION, PROJECT NO. HW2LP50065, TURQUOISE TRAIL
EXTENSION-CONSTRUCTION PROJECT**

WHEREAS, Santa Fe County and the New Mexico Department of Transportation have entered into a Transportation Project Fund Grant Agreement, Control No. HW2LP50065, for the Turquoise Trail Extension (the “Project”); and

WHEREAS, The purpose of this Agreement is to provide Transportation Project Funds (TPF) to the Public Entity for the following project scope Turquoise Trail Extension-Construction of the NM14 Turquoise Trail Multiuse Trail Extension from the intersection to NM 14 and Rancho Viejo Blvd to the NMRX-NM599 Station along NMDOT NM14 and Fire Place right-of-way; and

WHEREAS, the total cost of the project will be \$724,260.05 to be funded in proportional share by the parties as follows:

- a. The New Mexico Department of Transportation’s share is 95% or \$688,047.05; and
- b. Santa Fe County commits to its proportional share of 5% or \$36,213.00.
- c. The total Project cost is **\$724,260.05**.
- d. The Public Entity is responsible for all costs that exceed Project funding.

NOW, THEREFORE, BE IT RESOLVED by the Santa Fe County Board of County Commissioners that:

1. That the Project that is subject of Grant Agreement Control No. HW2LP50065 is adopted and has priority standing.
2. The Grant Agreement terminates June 30, 2027, and Santa Fe County incorporates all the agreements, covenants, and understandings between the parties concerning the subject matter of Grant Agreement Control No. HW2LP50065, and all such covenants, agreements and understanding have been merged into the Grant Agreement Control No. HW2LP50065.
3. Santa Fe County agrees to enter into the Grant Agreement Control Number HW2LP50065 with the New Mexico Department of Transportatin for the TPF Program for year 2025 for Turquoise Trail Extension-Construction of the NM14 Turquoise Trail

Multiuse Trail Extension from the intersection to NM14 and Rancho Viejo Blvd to the NMRX-NM599 Station along NMDOT NM14 and Fire Place right-of-way, within control of Santa Fe County in New Mexico.
