RESOLUTION NO. 2025 - 053

**A RESOLUTION GRANTING THE COUNTY MANAGER AUTHORITY TO
NEGOTIATE AND EXECUTE ALL DOCUMENTS NECESSARY FOR THE
ACQUISITION OF A PERMIT ACROSS SANTA CLARA PUEBLO LANDS
NECESSARY FOR MAINTAINING A DRAINAGE CHANNEL INTO THE SANTA
CRUZ RIVER**

WHEREAS, Santa Fe County Roads Department has constructed storm drain infrastructure near the Walnut Circle housing area; and

WHEREAS, this storm drain channel/ditch requires periodic maintenance and reconstruction to deliver storm water run-off into the Santa Cruz River; and

WHEREAS, due to realignment of the river, Santa Fe County Roads Department needs to cross Santa Clara Pueblo lands to accomplish this maintenance; and


WHEREAS, Santa Clara Pueblo has agreed to grant Santa Fe County a permit exclusively for the maintenance and reconstruction of a channel/ditch between Santa Fe County's storm drain infrastructure and the Santa Cruz River on and across Pueblo lands near the Walnut Circle housing area for a period of 10 years with an option to renew for an additional 10-year term.

NOW, THEREFORE, BE IT RESOLVED that the Santa Fe County Board of County Commissioners hereby:

1. Delegates to the County Manager the authority to negotiate and execute all documents necessary for the acquisition of a permit across Santa Clara Pueblo lands necessary for maintaining a drainage channel into the Santa Cruz River.



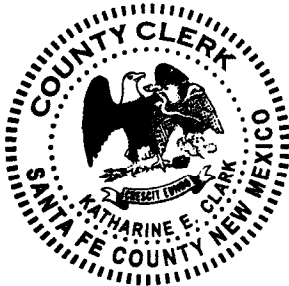


