A RESOLUTION AMENDING RESOLUTION 2025-019, CONFIRMING AND RATIFYING THE COUNTY MANAGER'S SIGNATURE APPROVING GRANT SAP 24-14215-GFR FOR THE ROMERO PARK WATERLINE PROECT AND DESIGNATING AN OFFICIAL REPRESENTATIVE, DESIGNATED AGENT AND NOTICE OF OBLIGATIONS CONTACT FOR SUCH GRANT

WHEREAS, in Subsection 14 of Section 66 of Chapter 81 of Laws 2020 the New Mexico Legislature made an appropriation for Grant 20-E3239 in the amount of \$275,000.00 to plan, design and construct meters and water line system extensions to provide service for Romero park, La Familia, the Nancy Rodriguez community center and the Agua Fria fire station in Santa Fe County; and

WHEREAS, in Section 213 of Chapter 65 of the Laws of 2024 the New Mexico Legislature made an appropriation to the New Mexico Environment Department (NMED), funds from which the NMED is making available to Santa Fe County to extend the project in Subsection 14 of Section 66 of Chapter 81 of Laws 2020 through fiscal year 2026; and

WHEREAS, Santa Fe County wishes to enter into Grant SAP 24-I4215-GFR with the NMED; and

WHEREAS, Santa Fe County agrees to accept and approve Grant SAP 24-I4215-GFR and designate who will be authorized the sign the grant agreement, designate an official representative who will be authorized to sign disbursement requests, designate an agent that will make quarterly updates to the CPMS database and designate a contact for Notice of Obligations (NOO) who will be authorized request NOOs be issued to Santa Fe County.

NOW, THEREFORE, BE IT RESOLVED that the Santa Fe County Board of County Commissioners that Resolution 2025-019 is hereby amended as follows:

- 1. Section 3 is deleted in its entirety and replaced with the following:
- "3. Samuel L Montoya, Capital and Grants Manager, is designated to make quarterly updates in the CPMS Database for SAP 24-I4215-GFR."
- 2. Section 4 is deleted in its entirety and replaced with the following:
- "4. Samuel L Montoya, Capital and Grants Manager, is designated as the contact for Notice of Obligation requests for Grant SAP 24-I4215-GFR."
