**A RESOLUTION TO AUTHORIZE CERTAIN GROWTH MANAGEMENT
DEPARTMENT STAFF AND THE ENFORCEMENT OFFICER FOR THE SOLID
WASTE DIVISION TO ISSUE CITATIONS FOR VIOLATIONS OF COUNTY
ORDINANCES, REPEALING AND REPLACING RESOLUTION NO. 2024-10**

WHEREAS, pursuant to NMSA 1978, Section 4-37-3, County Ordinances may be enforced by prosecution for violations of such Ordinances in any Court of competent jurisdiction of the County; and

WHEREAS, pursuant to NMSA 1978, Section 4-37-3 (B), prosecutions for violations of County Ordinances may be commenced by the issuance of a citation charging the violation; and

WHEREAS, pursuant to NMSA 1978, Section 4-37-3 (B), citations may be issued by County Code Enforcement Officers or other County employees who are authorized by the Board of County Commissioners to issue citations; and

WHEREAS, Santa Fe County will uphold County Ordinances by having Code Enforcement Officers tasked with issuing citations for violations to ensure compliance; and

WHEREAS, pursuant to Section 14.1.1 of Ordinance 2016-9, the Sustainable Land Development Code (SLDC), the Board shall annually appoint persons to serve as code enforcement officers and who will be primarily responsible for enforcement of the SLDC.

NOW, THEREFORE, BE IT RESOLVED by the Santa Fe County Board of County Commissioners that:

1. Santa Fe County Growth Management Department Code Enforcement Officers and the Solid Waste Division Enforcement Officer are commissioned and authorized to issue citations for violations of Santa Fe County Ordinances;
2. This Resolution repeals and replaces Resolution No. 2024-10;
3. The following officers are authorized and commissioned to issue citations charging violations of any and all County ordinances for which specific enforcement authority has not been exclusively granted to other County employees:
 - Joseph A Martinez – Code Enforcement Supervisor
 - Armando Rodriguez – Code Enforcement Team Lead
 - Robert Hollingsworth – Code Enforcement Senior Inspector
 - Frank Jones – Code Enforcement Senior Inspector

- Raymund Cabalona – Code Enforcement E Inspector
- John Lovato – Building & Development Supervisor
- Dominic Sisneros – Building & Development Supervisor
- Kenneth Quintana – Building & Development Team Lead
- Paul Portillo – Solid Waste Compliance Officer
- Rosemary Masters – Open Space Interpretive Ranger

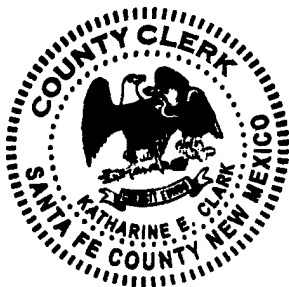
