**A RESOLUTION TO DELEGATE TO THE COUNTY MANAGER THE AUTHORITY  
TO NEGOTIATE FOR WORKERS' COMPENSATION COVERAGE FOR FISCAL  
YEAR 2026 AND EXECUTE PURCHASE ORDERS, AGREEMENTS, AND OTHER  
DOCUMENTS NECESSARY OR ADVISABLE TO EFFECTUATE SUCH COVERAGE**

**WHEREAS**, Santa Fe County (County), through its insurance broker, HUB International Services, Inc. (HUB) solicited proposals for workers' compensation coverage for the Fiscal Year 2026 (i.e. July 1, 2025 – June 30, 2026); and

**WHEREAS**, HUB evaluated six options from the New Mexico County Insurance Authority (NMCIA) and three options from New Mexico Mutual Casualty Company (NMM); and

**WHEREAS**, HUB has evaluated the proposed options and has indicated that the most advantageous proposal for the County is NMCIA's option of a \$100,000 deductible option at a premium of \$446,269 and expected retentions of \$374,397 for an expected total cost of insurance of \$820,666; and

**WHEREAS**, the Board of County Commissioners (Board) of the County has determined that NMCIA's option of a \$100,000 deductible option at a premium of \$446,269 and expected retentions of \$374,397 for an expected total cost of insurance of \$820,666, is the most advantageous proposal for workers' compensation coverage for the County; and

**WHEREAS**, the proposed contributions for NMCIA workers' compensation insurance exceeds the County Manager's general signature authority; and

**WHEREAS**, the Board desires to authorize the County Manager to negotiate with NMCIA for workers' compensation coverage for Fiscal Year 2026 and to execute on behalf of the County all purchase orders, agreements, and other documents necessary or advisable to effectuate such coverage.

**NOW, THEREFORE, BE IT RESOLVED** that the Santa Fe County Board of County Commissioners hereby delegates to the County Manager the authority to:

1. Negotiate with NMCIA for workers' compensation coverage for Fiscal Year 2026; and
2. To execute, on behalf of the County, purchase orders, agreements, and other documents necessary or proper to effectuate such insurance coverage.
