RESOLUTION NO. 2025 - 075

**A RESOLUTION TO DESIGNATE THE POLLING PLACES OF EACH
PRECINCT IN SANTA FE COUNTY, NEW MEXICO; CONSOLIDATE
PRECINCTS; AND CREATE AN ABSENTEE VOTER PRECINCT**

WHEREAS, NMSA 1978, Section 1-3-2, (2019) requires that, in June or July of each odd-numbered year, the Board of County Commissioners (Board) of Santa Fe County (County) by resolution must (1) designate the polling place of each precinct in the County; (2) consolidate any precincts pursuant to NMSA 1978, Section 1-3-4 (2023); and (3) create additional polling places in existing precincts pursuant to NMSA 1978, Section 1-3-7.1 (1991); and

WHEREAS, in order to make voting more convenient and accessible to voters, the Board wishes to permit voters in the County to cast ballots in statewide elections at voter convenience centers through the use of consolidated precincts pursuant to NMSA 1978, Sections 1-3-2(B) and 1-3-4 as set forth herein; and

WHEREAS, the Board finds that each polling place designated in this resolution complies with the provisions of NMSA 1978, Section 1-3-7 (2019); and

WHEREAS, the Board finds that those precincts that are consolidated to create Voter Convenience Centers (VCCs) meet the requirements of NMSA 1978, Sections 1-3-4 and 1-3-7, will be available to voters of any precinct in the county to cast a vote at the VCC, will make voting more convenient and accessible to voters of the consolidated precinct, will not result in delays for voters in the voting process, shall have a broadband internet connection and real-time access to the state-wide voter registration electronic management system, and are centrally located within the consolidated precinct; and

WHEREAS, for those consolidated precincts with more than one polling place, the Board finds that the interest of the convenience of the voters and providing accessibility to the polling place justifies the creation of additional polling places within the consolidated precinct; and

WHEREAS, the Board finds that none of the consolidated precincts designated herein are composed of more than ten precincts; and

WHEREAS, the Board of County Commissioners finds that each polling place set forth herein provides individuals with physical mobility limitations an unobstructed access to at least one voting machine; and

WHEREAS, recognizing that certain VCCs may receive a higher number of voters during general elections, the Board wishes to designate additional VCCs that will be used

only during general elections in the interest of the convenience of voters and providing accessibility to the polling place; and

WHEREAS, in accordance with NMSA 1978, Sections 1-6-20 and 1-6-22, the Board wishes to create the County Absent Voter Precinct, for absent voting purposes only, and designate polling places for such precinct that are open for delivering, registering, and counting absentee ballots.

NOW, THEREFORE, BE IT RESOLVED by the Santa Fe County Board of County Commissioners as follows:

Section 1. Consolidation of Precincts. Precincts in Santa Fe County shall be consolidated as set forth hereafter in Section 2 of this Resolution, Designation of Polling Locations. Any voter may vote in any consolidated precinct in Santa Fe County, regardless of precinct in which the voter resides.

Section 2. Designation of Polling Locations. The location and designation of each polling place for each precinct is set forth as follows:
