RESOLUTION NO. 2025 - 082

**A RESOLUTION TO AUTHORIZE THE DISPOSITION OF FIXED ASSETS
WORTH LESS THAN \$30,000 IN ACCORDANCE WITH STATE STATUTE**

WHEREAS, Santa Fe County ("County") desires to dispose of certain tangible personal property identified in Exhibit A; and

WHEREAS, Exhibit A describes items of tangible personal property by department, tag number, description of fixed asset, vehicle identification number, reason for surplus, condition of fixed asset, and estimated value; and

WHEREAS, NMSA 1978, Section 13-6-1 (2025) governs the disposition of tangible personal property belonging to a local public body that is (1) of a current resale value of thirty thousand dollars (\$30,000.00) or less; and (2) worn out, unusable or obsolete to the extent that the item is no longer economical or safe for continued use by the body; and

WHEREAS, the Board of County Commissioners hereby determines that each item of tangible personal property listed on Exhibit A (1) has an estimated resale value of \$30,000.00 or less and (2) is worn out, unusable or obsolete to the extent that the item is no longer economical or safe for continued use by the County.

NOW, THEREFORE, BE IT RESOLVED that the Santa Fe County Board of County Commissioners hereby:

1. Approves of the disposal of tangible personal property listed on Exhibit A in accordance with NMSA 1978, Section 13-6-1; and
2. Directs that, to the extent feasible and except as noted in the next paragraph, the tangible personal property shall be sold at public auction. If such sale is not feasible, the property shall be disposed of as allowed by law.
3. Finds that the items noted in Exhibit A as "To Be Destroyed" are hazardous and may not be used safely under any circumstances, as required by NMSA 1978, Section 13-6-1(H).



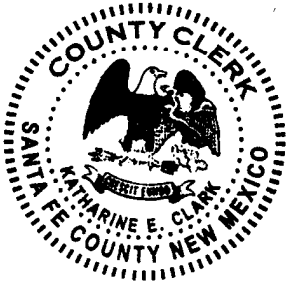

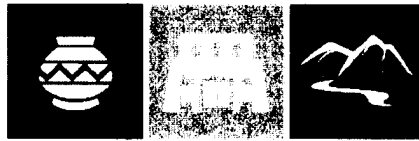

Resolution No. 2025-____, A Resolution to Authorize the Disposition of Fixed Assets Worth Less Than \$30,000 in Accordance with State Statute

SUMMARY:

Santa Fe County wishes to dispose of personal property by means of sale at public auction, but if that is not feasible, it shall be disposed of as otherwise allowed by law.

BACKGROUND:

Santa Fe County follows Sections 13-6-1 through 13-6-2 NMSA 1978 to dispose of surplus property and equipment. Each Santa Fe County department/elected office participates in the process to review the damaged, broken, or obsolete fixed assets inventory to determine whether the assets are usable, safe for continued use, or if the cost to repair the item would be excessive. The Information Technology (IT) Division reviews electronic items, and vehicles are reviewed by the Public Works Fleet Division to determine eligibility for surplus.

The subject resolution authorizes the disposal of personal property listed in Exhibit B and directs that it be sold at public auction (except as noted below). If a public auction sale is not feasible, the County may dispose of the property by other lawful means, which include the following:

1. by negotiated sale to any governmental unit of an Indian nation, tribe or pueblo in New Mexico;
2. by negotiated sale or donation to other state agencies, local public bodies, school districts or municipalities;
3. by sale or, if the property has no value, donation to a 501(c)(3) corporation; or
4. destruction.

Certain personal property is designated in Exhibit A to the resolution "To Be Destroyed". Examples include tasers, lapel cameras, and radios. This is based upon a determination that the equipment is hazardous and may not be used safely by the public under any circumstances.

RECOMMENDED ACTION:

Approve this resolution to dispose of personal property. Upon approval, a copy of the resolution will be submitted to the New Mexico Office of the Auditor (OSA) for notification. The listed items will be disposed of 30 days after notification to the OSA.
