RESOLUTION NO. 2025 - 089

**A RESOLUTION TO ESTABLISH A COMMUNITY ORGANIZATION FOR
THE COMMUNITIES OF TRES ARROYOS, LAS CAMPANAS,
AND WEST TANO ROAD**

WHEREAS, on October 27, 2015, the Santa Fe Board of County Commissioners (BCC) adopted the Sustainable Growth Management Plan (SGMP) and designated it as the comprehensive plan for Santa Fe County as prescribed by New Mexico law, including but not limited to NMSA 1978, Section 3-21-5; and

WHEREAS, the SGMP provides that Santa Fe County will establish Community Organizations (CO) "for communities and community-oriented organizations to have an improved public participation process to meet community needs and to make recommendations with respect to development projects and community development issues;" and

WHEREAS, on December 13, 2016, the Santa Fe Board of County Commissioners adopted Ordinance No. 2016-9, the Sustainable Land Development Code (SLDC), which governs land use and development throughout the unincorporated areas of Santa Fe County; and

WHEREAS, the SLDC, at Section 2.2.2.2, defines a CO as a "new or pre-existing association or organization that is recognized by resolution of the Board to represent a specified geographical area within the County;" and

WHEREAS, the SLDC, at Section 2.2.2, identifies the process for BCC recognition of CO's, and enumerates the rights and responsibilities of CO's; and

WHEREAS, pursuant to SLDC, at Section 2.2.2., Northwest Santa Fe Community Association has properly applied to be recognized as the CO representing the communities of Las Campanas, Tres Arroyos, and west Tano Road.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Santa Fe County that the Northwest Santa Fe Community Association is hereby recognized as the CO for the communities of Tres Arroyos, Las Campanas, and west Tano Road.

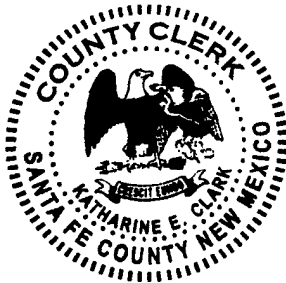
