RESOLUTION NO. 2025 - 690

A RESOLUTION TO AUTHORIZE THE DISPOSITION OF FIXED ASSETS WORTH LESS THAN \$30,000 IN ACCORDANCE WITH STATE STATUTE

WHEREAS, Santa Fe County ("County") desires to dispose of certain tangible personal property identified in Exhibit A; and

WHEREAS, Exhibit A describes items of tangible personal property by department, tag number, description of fixed asset, vehicle identification number, reason for surplus, condition of fixed asset, and estimated value; and

WHEREAS, NMSA 1978, Section 13-6-1 (2025) governs the disposition of tangible personal property belonging to a local public body that is (1) of a current resale value of thirty thousand dollars (\$30,000.00) or less; and (2) worn out, unusable or obsolete to the extent that the item is no longer economical or safe for continued use by the body; and

WHEREAS, the Board of County Commissioners hereby determines that each item of tangible personal property listed on Exhibit A (1) has an estimated resale value of \$30,000.00 or less and (2) is worn out, unusable or obsolete to the extent that the item is no longer economical or safe for continued use by the County.

NOW, THEREFORE, BE IT RESOLVED that the Santa Fe County Board of County Commissioners hereby:

- 1. Approves of the disposal of tangible personal property listed on Exhibit A in accordance with NMSA 1978, Section 13-6-1; and
- 2. Directs that, to the extent feasible and except as noted in the next paragraph, the tangible personal property shall be sold at public auction. If such sale is not feasible, the property shall be disposed of as allowed by law.

Re: Equipment/Improvements as Part of Assets to be Destroyed

The purpose of this memo is to serve as an explanation regarding the additional equipment and improvements that share asset numbers with the 47 fleet vehicles that are listed on the surplus forms we submitted for auction.

The 47 fleet vehicles listed on the suplus forms we submitted are all law enforment vehicles, and contain additional equipment and improvements that share asset numbers with the vehicle they are installed in. The equipment and improvements are what make these vehicles law enforment vehices and cannot and should not be sold at auction to the public.

With the pace that technology advances the electronics and technical equipment has reached end of life and is no longer supported by manufactures. The remaining equipment such as prisioner partions and center consoles for example are all year, make, model specifc rendering it unusable for transfer to other new law enforment vehicles. For this reason prior to auction all of these vehicles will be fully decommisioned and all equipment and improvements to the vehicles will be removed and destroyed. The removal and destruction of this equipment helps ensure the the vehicle that remains is suitable and safe for public use. Thank you for your assistance.
