**A RESOLUTION AUTHORIZING THE COUNTY MANAGER TO SECURE  
MULTI-LINE, LAW ENFORCEMENT, AND OTHER INSURANCE COVERAGES  
FOR CALENDAR YEAR 2026; TO FINALIZE NEGOTIATIONS FOR  
SUCH COVERAGES; AND TO EXECUTE ALL DOCUMENTS NECESSARY TO  
EFFECTUATE SUCH COVERAGES**

**WHEREAS**, Santa Fe County (County) received deductible coverage and coverage options for multi-line, law enforcement, and other insurance coverages for calendar year 2026; and

**WHEREAS**, the Board of County Commissioners (Board) has determined that securing such coverages from the New Mexico County Insurance Authority (NMCIA) is most advantageous to the County because, among other reasons, NMCIA is a joint powers agreement entity created by member counties to pool risk for the long-run, has robust loss prevention services tailored to the needs of counties, and offers competitive coverage options; and

**WHEREAS**, the contributions and premiums for such coverages will exceed the County Manager's general signature authority; and


**WHEREAS**, the Board desires to authorize the County Manager to finalize the details of such coverages with NMCIA for calendar year 2026, including deductibles, negotiate with NMCIA for such coverages, and to execute on behalf of the County all purchase orders, agreements, and other documents necessary or advisable to effectuate such coverages.

**NOW, THEREFORE, BE IT RESOLVED** that the Board hereby delegates to the County Manager the authority to:

1. Finalize the details of multi-line, law enforcement, and other insurance coverages offered by or through NMCIA for calendar year 2026, including deductible options designed to yield the lowest total cost of risk without taking on material amounts of risk;
2. Negotiate with NMCIA for such coverages for calendar year 2026; and
3. Execute on behalf of Santa Fe County purchase orders, agreements, and other documents necessary or advisable to effectuate such coverages.

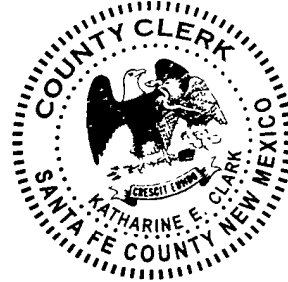


