RESOLUTION NO. 2026- 018

**A RESOLUTION ADOPTING PROJECTS FOR INCLUSION IN SANTA FE
COUNTY'S INFRASTRUCTURE CAPITAL IMPROVEMENT PLAN (ICIP) FOR
FISCAL YEARS 2027-2031; AUTHORIZING SUBMITTAL OF PLAN TO THE NEW
MEXICO DEPARTMENT OF FINANCE AND ADMINISTRATION (DFA); AND
REPLACING RESOLUTION 2025-125**

WHEREAS, the Board of County Commissioners (the "Board") of Santa Fe County recognizes that the financing of public capital projects is an important aspect of local government; and

WHEREAS, it is necessary to access multiple financing mechanisms in order to maximize capital resources; and

WHEREAS, capital improvements planning is an effective tool to help prioritize projects that should be developed and identify concrete actions and strategies to achieve project development; and

WHEREAS, short- and long-range capital planning contributes to local and regional efforts to identify and select projects; and

WHEREAS, a list of projects for inclusion in the County's Infrastructure and Capital Improvements Plan (ICIP) for Fiscal Years (FY) 2027-2031 was developed in a series of meetings among citizens, staff, and elected officials from various levels of government; and

WHEREAS, the Board reviewed the list of potential projects at its meetings on June 24, 2025, July 8, 2025; and

WHEREAS, that list of projects was adopted by the Board through Resolution 2025-080 in July of 2025; and

WHEREAS, that list of projects was updated to incorporate revisions to the prior list presented at the meeting which took place on November 10, 2025; and

WHEREAS, at its January 13, 2026, meeting, the Board approved Santa Fe County acting as Fiscal Agent for capital outlay appropriations made during the 2026 Regular Legislative Session for projects proposed by Interfaith Community Shelter Group Inc. and Entrepreneurial Institute of Northern New Mexico (EINNM): namely, the Resource and Opportunity Center (ROCK) and a transitional housing facility, respectively.

NOW, THEREFORE, BE IT RESOLVED by the Santa Fe County Board of County Commissioners that:

1. The Board hereby adopts as Santa Fe County's FY 2027-2031 ICIP the list of projects that staff presented to the Board at its January 27, 2026, meeting. The list of projects is attached as Exhibit D.
2. Staff shall submit the ICIP to the State of New Mexico, Department of Finance and Administration, and prioritize the projects in accordance with the Board's comments.
3. This Resolution replaces Santa Fe County's Resolution No. 2025-125.

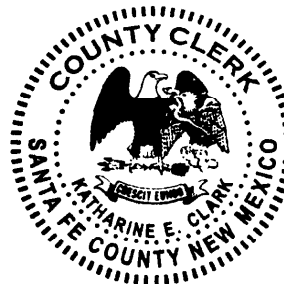
