RESOLUTION NO. 2026 - 043

**A RESOLUTION TO AUTHORIZE THE DISPOSITION OF FIXED ASSETS
WORTH LESS THAN \$30,000 IN ACCORDANCE WITH STATE STATUTE**

WHEREAS, Santa Fe County (“County”) desires to dispose of certain tangible personal property identified in Exhibit A; and

WHEREAS, Exhibit A describes items of tangible personal property by department, tag number, description of fixed asset, vehicle identification number, reason for surplus, condition of fixed asset, and estimated value; and

WHEREAS, NMSA 1978, Section 13-6-1 (2025) governs the disposition of tangible personal property belonging to a local public body that is (1) of a current resale value of thirty thousand dollars (\$30,000.00) or less; and (2) worn out, unusable or obsolete to the extent that the item is no longer economical or safe for continued use by the body; and

WHEREAS, the Board of County Commissioners hereby determines that each item of tangible personal property listed on Exhibit A (1) has an estimated resale value of \$30,000.00 or less and (2) is worn out, unusable or obsolete to the extent that the item is no longer economical or safe for continued use by the County.

NOW, THEREFORE, BE IT RESOLVED that the Santa Fe County Board of County Commissioners hereby:

1. Approves of the disposal of tangible personal property listed on Exhibit A in accordance with NMSA 1978, Section 13-6-1; and
2. Directs that the property listed in Exhibit A will be disposed of as follows: the defibrillators will be returned to the manufacturer for recycling and a respirator fit tester will be traded in for new equipment. If such disposal is not feasible, the property shall be otherwise disposed of as allowed by law.

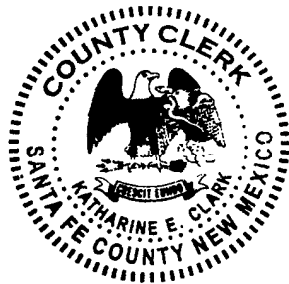
