RESOLUTION NO. 2026 - 061

**A RESOLUTION REQUESTING AN EXTENSION OF A COOPERATIVE
AGREEMENT WITH THE NEW MEXICO DEPARTMENT OF TRANSPORTATION
FOR PROJECT NO. HW2LP50048, LOS PINOS ROAD AND BRIDGE
CONSTRUCTION**

WHEREAS, pursuant to NMSA 1978, Section 67-3-28 and 67—78 and 18.27.6 NMAC, assistance for local and road construction and repair is available through the New Mexico Department of Transportation (NMDOT) from the Transportation Project Fund (TPF); and

WHEREAS, on May 14, 2024, the Board of County Commissioners (Board) adopted Resolution No. 2024-067 (Exhibit A) supporting the construction of a portion of Los Pinos Road and related bridge work in Santa Fe County (the “Project”), approving a Cooperative Agreement with NMDOT for the Project’s completion, and verifying the Project’s priority status; and

WHEREAS, the completion of the Project was delayed because of a partial suspension of construction during the winter holiday period and unforeseen utility conflicts encountered during construction; and

WHEREAS, the County’s Public Works Department reviewed the contractor’s explanation for these delays and recommends supporting the time extension, resulting in a total contract time increase of 35 calendar days; and

WHEREAS, the Cooperative Agreement terminates on June 30, 2026; and

WHEREAS, the County Public Works Department desires to request from NMDOT an extension of the June 30, 2026, deadline to September 30, 2026; and

NOW, THEREFORE, BE IT RESOLVED that the Santa Fe County Board of County Commissioners hereby:

1. Requests that NMDOT extend the term of the Cooperative Agreement from June 30, 2026, to September 30, 2026, to complete the Project; and
2. reaffirms the Project’s priority status.

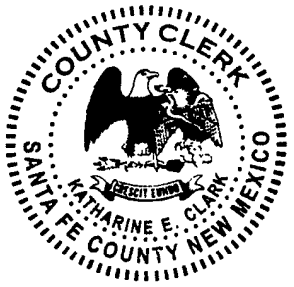
